Dear Toshi and Family and Team OGBI,

Thank you so much for supporting Reach Out WorldWide and bringing Drive4Paul to Japan! Your support has helped continue Paul's legacy and fulfill his vision for spreading good will to those who need it most.

These past few months have been very busy for ROWW as major disasters keep pummeling one after another. We've deployed to North Carolina in response to Hurricane Florence, Indonesia in response to the devastating earthquake and tsunami, and Florida to assist those affected by Hurricane Michael. We couldn't do it without the generous contributions from supporters like you.

In North Carolina we've put over 35 volunteers to work for five weeks mucking and gutting flooding homes, helping with mold abatement, tarping roofs, helping clear downed trees and debris, and rescuing families immediately after Hurricane Florence. We've logged over 2400 hours and saved residents of North Carolina well over \$150,000.

During the first few days following landfall of Hurricane Florence, our Phase 1 team was able to assist with over 100 rescues. Our team was able to get in early, so we were the only relief team in Wilmington alongside the Cajan Navy as water levels rose and roadways became inaccessible. Our team worked around the clock for nearly 48 hours as we helped evacuate residents and rescue families from their home via boat.

Water levels in Wilmington and the surrounding area continued to rise for over a week. In some instances, water filled homes with over 4-feet of water for nearly two weeks. Unfortunately, many of those homes will be a complete loss. But for many others, we are able to help them start the recovery process by clearing their furniture and homes' contents and begin mucking out the water-logged carpet, sheet rock, insulation, cabinets, etc.

As we started our transition from Phase 1 to Phase 2 in NC, ROWW received notification of the 7.5 earthquake that struck Donggala, Indonesia. The quake was followed by a 20-foot tsunami that crashed into the shoreline at 500+ mph – a shoreline that was packed with over 1000 people that were celebrating a carnival. Sadly, most of those people passed away along with thousands of others across the region.

Our team arrived in Indonesia just days after the event and we were tasked out to the local disaster response management team, BNPB. They supplied us with helicopters for transport to areas that had been unreachable by other medical teams. ROWW was able to provide medical aid to over 200 patients and deploy 20 water systems to remote villages. Each water system has a life of 1,000,000 gallons of water.

Immediately following Game4Paul4, our team deployed to Florida to assist residents affected by Hurricane Michael – a storm that barreled into the state as a Category 4 (almost Cat 5!) storm and has left unimaginable destruction like what you'd expect from an EF3 tornado. Our team is helping with tree removal, roof tarping, and general assistance as needed.

Thank you for your donation that makes deployments like these possible. Together, we are able to help so many of those that need it most.
